- 2. **Board Meeting Minutes:** Chase moved to approve the minutes of the July 24, 2023 Regular Meeting and the August 8, 2023 Special Meeting. Ross seconded; all in favor; motion passed.

- 4. **Public Hearing:** Tom opened the Public Hearing on the District's proposed 2023 Ad Valorem Tax Rate of \$0.10 per \$100 valuation, consisting of a Debt Rate of \$0.00 per 100 valuation and a Maintenance and Operations Rate of \$0.10 per \$100 valuation at 5:03 p.m.
